2019 Post Season Information and Commitment Agreement



The following information and policies have been prepared and adopted by the Carpinteria Valley Girls Softball League for their 2019 Post Season.

TO BE CONSIDERED FOR ALL-STARS THE FOLLOWING ARE DUE BY ASAP:

- 1) SIGNED COMMITMENT AGREEMENT,
- 2) REGISTRATION FEE
- 3) VOLUNTEER DEPOSIT CHECK
- 1. The selection process for each division is as follows:
 - Managers of each division will rate all interested players in their own division based on their individual observations during regular season games which include hitting, throwing and fielding skills. All of these will be factored into the rating as well as <u>attendance</u> and <u>attitude</u> during recreational softball.
 - Tryout dates are TBD.
 - All-Star teams will consist of a roster of 12 players. The Post Season Coordinators will
 compile the ratings and the 14 highest rated players will be filtered out. Of those 14, the 9
 highest rated players will automatically be placed on the 2019 All-Star Team. The All-Star
 Manager will then fill the remaining 3 spots by choosing from the residual list.
- 2. Selected players must make a commitment to attend <u>ALL</u> team practices. Practices will generally be held **2-3 times a week for 2 hours each**. Each Divisional All-Star Manager will finalize their individual practice schedules.
- 3. The following is a list of tournaments we plan on attending. Players interested in participating in the Post Season <u>must make a commitment</u> to participate in <u>all</u> the listed tournaments and be available to attend on these following <u>tentative</u> dates:
